1. ARTICLE I, Members, Section 4, of the By-Laws be amended to read as follows:

Section 4. A quorum at membership meetings shall consist of attendance in person or by proxy of members entitled to cast thirty percent (30%) ~~a majority~~ of the votes of the entire membership. The joinder of a member in the action of a meeting by signing and concurring in the minutes thereof shall constitute the presence of such person for the purposes of determining a quorum.
